2.1 Monthly update

- CIr Greco provided State Govt Planning Reforms hard copies for all. A webinar will be on Wednesday 14th February to present the reforms.
- Clr Greco mentioned council rate rise has been agreed
- DR asked about Post Office and if there was a further update. Clr Greco no further update at this stage.
- Cr Greco shared an update on the recent council meeting:
 - The Special Rate Variation of 15% has been voted on. The next step is for it to go to the <u>Independent Pricing and Regulatory Tribunal (IPART)</u> for further community consultation.
 - Bulky waste services remain unchanged.
