## Inaccessible eastside access to Artarmon train station

The Artarmon Progress Association, on behalf of the Artarmon community, is writing to request Disability Discrimination Act (DDA) compliant access between Wilkes Avenue and the Artarmon train station.

The Artarmon Progress Association has raised this issue with Willoughby City Council. The Council has stated it is unable to address the problem given the NSW Government owns the land between Wilkes Avenue and the station.

Currently, people with disabilities and impaired mobility living on the Wilkes Avenue side of Artarmon have two options to access the train station and Hampden Road shops:

- Use the non-DDA compliant ramp that runs between Wilkes Avenue and the station. Parts of the ramp exceed 10 degrees (steeper than 1:6). DDA compliance requires a gradient no steeper than 7 degrees (1:8); or
- Use Valetta Lane and Brand Street, an uneven footpath that is 450 metres long.

Both of these options are unreasonable and unsafe.

For many years the Artarmon community has expressed a strong need for station lift access via both Hampden Rd and Wilkes Avenue. In 2015 the NSW Government installed two new lifts that provide access from Hampden Road to the Artarmon station platform. Many in the community remain bitterly disappointed that lift access to the station was not also provided via Wilkes Avenue at the same time.

We are aware that the NSW Government has set a target to increase the roles held by people with disability in the public sector from an estimated 2.7 per cent to 5.6 per cent by 2025. For many people, especially those managing a disability, public transport is essential for accessing employment.

The Artarmon Progress Association is calling on the NSW Government to provide DDA compliant access to Artarmon train station via Wilkes Avenue by either installing a lift or creating a DDA compliant walkway. An illustration of a DDA compliant walkway is provided.


